
The politics /technology of the COVID-19 vaccine 新冠疫苗里面的政治和技术

关于新冠疫苗的政治化和民族化,下面这张图可以看到,中国产的是第一和第3种,西方产的是第二和第4种,中国疫苗被接种的数目最多,原因之一是中国人口体量大,原因之二是中国的疫苗对外出口量要大,除了美国和其他几个很少的几个国家没有用中国的疫苗之外。

THE RACE TO VACCINATE

Out of the eight vaccines that account for the vast majority of COVID-19 vaccine doses delivered globally, China's CoronaVac and Sinopharm jabs account for nearly half of all doses.

背景

Four vaccines are currently approved for use in the EU: **Pfizer-BioNTech**, Moderna, AstraZeneca and Johnson & Johnson. Another four are under "rolling review" for possible approval: Russia's Sputnik, **China's Sinovac**, Germany's CureVac and Novavax of the United States. (straitstimes.com/July 01, 2021) .

中国,以国药中生公司为代表,灭活疫苗,包括国药中生北京公司、国药中生武汉公司、北京科兴中维公司,Sinovac COVID-19 vaccine,北京科兴中维新冠疫苗;Sinopharm COVID-19 vaccine (Beijing);国药北京所新冠疫苗Sinopharm COVID-19 vaccine ;Wuhan)国药中生武汉公司新型冠状疫苗

外国,以辉瑞公司为代表,辉瑞公司(Pfizer Inc.)的 BNT162,RNA 疫苗或 mRNA(信使 RNA)疫苗是一种新型疫苗,它将病毒 mRNA 片段插入人体细胞中,通过重编程产生病原体抗原(如针刺蛋白或癌症抗原),然后激发针对病原体的适应性免疫反应,与传统蛋白疫苗相比,RNA 疫苗的优势在于生产速度快、成本低,可诱导细胞免疫以及体液免疫,需要冷链配送和低温储存。

美国研制的疫苗 mRNA

mRNA 旨在将抗原的遗传信息引入人体,mRNA 疫苗易大规模生产等优势。 **辉瑞公司 (Pfizer Inc.)** 的 BNT162b2 疫苗需要在超低温环境中(零下 70°C) 储存,在 2~8°C只能存储 24 小时,技术发明人罗伯特 马龙对于 mRNA 有他自己的客观性的评论,但是受到主体媒体的剧烈反对,因为对他们的商业利益有巨巨大损害,https://zhuanlan.zhihu.com/p/446442807,

Billions of shots of China's CoronaVac and Sinopharm vaccines have been given globally, but studies have questioned the length of protection they offer.

A number of countries are already offering third doses to all adults or are trying mix-and-match approaches. Some experts are even questioning whether China's jabs — based on inactivated virus — should continue to be used at all when other options are available.

(In general, what I understand is that the Chinese vaccines are more conservative than the Western vaccines, in other words, safer... 两者都跟基因的植入相关,但是美式的疫苗做的激进一些,过分一些)

Both the Chinese vaccines are **inactivated vaccines**, which use killed SARS-CoV-2 virus. Researchers say this type of vaccine seems to be less potent because it triggers an immune response against many viral proteins. By contrast, mRNA and viral-vector vaccines target the response to the **spike protein**, which is what the virus uses to enter human cells.

China was ready to approve Western mRNA vaccines months ago. Why is it still holding off? (下面就是 CNN 文章对中国为什么不用美国疫苗的微词)

The limited protection provided by Chinese vaccines is far from enough to satisfy China's ambitious goal of keeping Covid infection at zero within its borders. Over the past few months, authorities have resorted to increasingly stringent measures to curb local outbreaks -- often at great economic cost and disruption to daily lives.

Over the weekend, **Zhong Nanshan**, 钟南山, a top Chinese respiratory disease expert and government adviser, urged China to increase exchanges and cooperation in vaccine development with other countries.

"We need to learn about the good things in other countries, such as mRNA (vaccines)," Zhong said at a forum in the southern city of Guangzhou Saturday.

"They've spent years on the research and managed to develop the world's first mRNA (vaccine) in just a few months...We need to learn from their technology in this area," he said.
